Note: To claim an application commission for a applying a grower's purchased Bayer seed treatment, a copy (photocopied or scanned) of the grower's purchase invoice must be attached. The invoice must clearly state the date of purchase, company name, ABN, contact information, Bayer products purchased, quantity of Bayer products purchased and amount paid.



## Terms and Conditions of G Team Membership and Application Commission Rebate Program

- 1. To claim an application commission rebate (rebate) on purchased Bayer CropScience seed treatment products, the participant must produce a copy (photocopied or scanned) of an original invoice complete with date, company name, ABN, contact information, name of Bayer products purchased, quantity of Bayer products purchased and amount paid. This must be submitted on or before the 31st October 2014 for a rebate to be issued. Participants submitting incomplete rebate requests that do not include the above information will not be eligible for a rebate payment.
- 2. To qualify for a rebate, Bayer CropScience seed treatment products must be purchased between 1st November 2013 and 31st October 2014 (includes these dates).
- 3. Bayer CropScience will only issue one rebate for each Bayer CropScience product purchased. Participants cannot receive multiple rebates from one product purchased.
- 4. It is the responsibility of the participant to ensure that any invoices submitted as part of a rebate request are accurate and include any adjustments for any Bayer CropScience seed treatment product that is returned, credited or refunded to the place of purchase.
- 5. Bayer CropScience reserves the right to contact stores or resellers to verify the sales captured in submitted invoices.
- 6. If a participant seeks to receive an application commission on a Bayer seed treatment that has been purchased by a grower (not a seed grader), he/she must complete and submit the 'Bayer Seed Treatment Application Commission' form. This form must be completed and signed by both the seed grader who applied the product, and the grower who purchased the product from a store. It must be accompanied by a copy of the purchaser's invoice for the Bayer seed treatment.
